<p>Recognize that a whole number is a multiple of each of its factors. Determine whether a given whole number in the range 1-100 is a multiple of a given one-digit number. <p>informally why the numbers will continue to alternate this way.</p> <p><u>Number and Operations in Base Ten:</u></p> <p>4.NBT.1 – Recognize that in a multi-digit whole number, a digit in one place represents ten times what it represents in the place to its right. For example, recognize that $700 / 70 = 10$ by applying concepts of place value and division.</p> <p>4.NBT.2 – Read and write multi-digit whole numbers using base-ten numerals, number names, and expanded form. Compare two multi-digit numbers based on meanings of the digits in each place, using $>$, $<$, and $=$ symbols to record the results of comparison.</p>	<p>perpendicular and parallel lines.
