The Jasper City Board of Education met on May 24, 2019 at 7:30 a.m. in the Central Office Conference Room. Members present were Willie Moore, Walker Wilson, Scott Thornley, Mary Beth Barber, and Teresa Sherer. Superintendent Dr. Ann Jackson was also in attendance.

Chairperson Willie Moore called the meeting to order with the first item to be approved being the agenda. A motion to approve the agenda was made by Teresa Sherer and a second by MaryBeth Barber. The motion carried.

The Superintendent recommended adoption of a motion to approve the following personnel actions for items 1-10:

7. Approve the employment of Jackee Carol Key as special education teacher (self-contained) at Jasper High School effective August 1, 2019.
